1. Office of the Rural Municipality Executive Bariyarpatti invites sealed bids from eligible bidders for the construction of Building Construction under National Competitive Bidding procedures.

A complete set of Bidding Documents may be purchased from the Office of the Rural Municipality Executive Bariyarpatti, Siraha by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, VAT and PAN Registration Certificate, Tax Clearance certificate for the Fiscal Year 2076/077 and upon payment of a non-refundable fee of NRS 3000 till 2077/10/02 during Office hours.
4. Sealed bids must be submitted to the Office of the Rural Municipality Executive Bariyarpatti, Siraha by hand on before 2077/10/03 on 12:00 PM. Bids received after this deadline will be rejected.
5. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2077/10/03 at 2:00 PM at the Office of the Rural Municipality Executive Bariyarpatti, Siraha. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security, amounting to a minimum of specified table below, which shall be valid for 30 days beyond the validity period of the bid.
6. If bidder wishes to submit the Bid Security in the form bidder has to Deposit Account maintained at Prabhu Bank Account No: 1470116082600046, Bariyarpatti Branch and submit bank Deposit voucher along with the bid.
7. If the last date of purchasing, submission and opening falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
8. Pre-bid meeting shall be held at Office of the Rural Municipality Executive Bariyarpatti, Siraha at 2077/09/19.
9. The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning any reason, whatsoever.
